<p>* Hanse Carlse (Toll).....Hans Carelsen Toll.....Carlesen the Norman. He was also known as Hans Carelsen van Langesund (Langsant).....Langesund being a town in Norway.</p> <p>As early as 1658 he owned and operated a cargo vessel on the Hudson River between New Amsterdam (NYC), Wiltwyck (Kingston) and Beverwyck (Albany). He owned a house in Beverwyck (Albany) near the main road and Pearl St. as well as a house in Wiltwyck (Kingston)</p> <p>In the NY Calendar of Historical Manuscripts,vol I., p. 43. is a reference to Hanse Carlse TOLL::</p> <p>"Not a few owned yachts and boats, and were engaged in fishing, freighting lumber and other merchandise on the Hudson, or the Delaware. Laurens Laurensen, Norwegian, used several yachts for timber transport. He also built yachts for the market. One of them "Swarten Arent" (Black Eagle) was valued at fl. 1400. Hans Carlsen, Norwegian, sailed a large boat and employed hired men on it. Christian Pietersen, a Dane, plied his boat up and down the Hudson. The Swedes Jan Jansen and Roelof Teunissen commanded larger ships. Danes like Bording, Kuyter, Bronck were experienced navigators. Norwegians like Albert and Arent Andriessen were used to the seas. The great ship "New Netherland," built at Manhattan, was the work of Scandinavian carpenters, engaged by Pieter Minuit. It was of 600 to 800 tons burden, fitted to carry thirty guns. "It was one of the largest merchantmen afloat, and not for two hundred years was another as large launched in the same waters. Sent at once to Holland and employed in the West India trade, everywhere it excited wonder by its size and by the excellence and variety of timber used in its construction."</p> <p>A clue into his wife's name and familial lineage came in the will of Jacob Janse Schermerhorn, his brother-in-law. In which it identifies Schermerhorn's wife as Jannette Cornelieszn.....Jannete was a sister to Neeltie....as shown in the ship passenger lists of Mar 1644 (ship name Wapen de Rensellaerwyck) when the Seegersz family arrived in New Amsterdam from Holland. Neeltie was the youngest child, and Jannettie the next eldest. (See family lineage of Cornelius Seegersz van Voorhout...some lineage of this family line use the surname Egmont which derives from the Dutch town Egmont near where Cornelius Seegersz came from..ie Voorhout)</p> <p>Hanse Carlse Toll's home in Wiltwyck (Kingston) was burned in the second (2nd) Esopus Indian War of 1663. (NYS archives)</p> <p>His first (1st) wife Neeltje Seegerz died in 1667 and in 1671 he re-married to Geertje Teunis. He died prior to May 20, 1685, when his 2nd wife, Geertje Teunis re-married. (ref. NYS Historical Society, "History of Beverwyck")</p> <p>He was identified in numerous documents and records of the early Dutch settlements in Albany, Kingston, and NYC.(on file NYS archives)</p>

Interesting note:

NYC Dutch Reformed church records between 1639 and 1647 show at least 1 other individuals that may possibly be related to Hanse Carlsen Toll (Carlesen de Norman).....he is Hans Hanse de Norman...(naming patronymics indicate he was Hans son of Hanse de Norman).....a side note is that one of the children of one of this possible (Hans) had as a sponsor "d'Hr,(The honorable) Willem Kieft" (who was the Governor General of the Dutch West India Co at the time, and overall Governor of the New Amsterdam colony for the DWI Company, just prior to Pieter Stuyvesent-1647)

With Hanse Carlse Toll being a prominent ship Captain and having a cargo vessel that plied the trade for the New Amsterdam colony and later up and down the Hudson, the family would have been in a social position that would have warranted an influential sponsor to one of their children....such as is evidenced in the DRC records....(all of which further helps indicate the possible relationship between 1639-1647 to our Hanse Carlsen Toll)

ALSO From NYS archives:

Hans Carelsen, or Hans Carelsen Noorman, was from Norway. He settled in Beverwyck and married Neeltje, a daughter of Cornelis Segersen van Vorhoudt (who had come to Beverwyck in 1644) and wife, Brechtje Jacobs.

Hans Carelsen Toll's wife, Neeltje Corneliese Seegersz was, at the arrival of her family into the new world, eight years of age, the youngest of six children.(48 J. Munsell, Collections on the History of Albany, IV., p. 144.)

Hans Carelsen was a fur-trader and ship Captain. An entry under date of August 6, 1657, shows that he sent down from Albany to New Amsterdam 2,300 beavers, and in the following month of September, 1,100 beavers.(49 The Records of New Amsterdam 1653-1674, III., p. 31.)

In August, 1659, Geertje Hendricks sued him for a balance of 12 beavers and fl. 18 in seawan ( native shell/beads money ie wampum). In his defense Carelsen claimed that he had paid her more than what belonged to her, as the other half concerned Jacob Coppe, deceased. The contract was then produced in court, whereupon Carelsen admitted that he owed the sum demanded. He said, however, he could not pay it at present. But the court ordered him to pay it if he wanted release from arrest(.50 Ibid., III., p. 387.)

In October, 1661, he was again engaged in litigation, this time suing Pieter Ryverdinck, who owed him a sum of money for freighting goods to Ft. Orange.(51 Year Book of the Holland Society of New York, 1900, p. 140. [p.45])

In Sept `1661 he is listed amongst others as owing money (40 guilders) on a list of persons at Ft Orange (Albany, NY) (pg 112 Early Albany Notarial Records, Pearson & Van Laer)

On April 11 1662, he signed his name on a contract to deliver board via yacht (Early Notarial Records of City and County of Albany, pg 152)

On April 22, 1662, he signed his name as a witness at the conveyance of a yacht.(52 J. Munsell, Collections on the History of Albany, IV., p. 319.)

In 1662-1663 he wanted to sell his house near Beverwyck. We have an imperfect and unsigned paper stating the condition on which he proposed "to sell at a public sale to the highest bidder his house and lot lying near the village of Beverwyck by the side of the hill on the plain where he at present dwells."(53 New York Colonial Documents, XIII., p. 247.)

On June 7, 1663, his house at Wiltwyck was burnt by Indians.(54 The Records of New Amsterdam 1653-1674, V., p. 126.)

In January, 1664, a carpenter brought suit against Carelsen for the amount of twenty-four and a half guilders for wages earned on the boat Carelsen was sailing. Though it was shown that the plaintiff had run away from his work, the court ordered Carelsen to pay the sum sued for.(.55 Ibid) He had engaged the carpenter for a year at the rate of 26 gl. per month.( Ibid., VI., p. 43)

In 1666 Carelsen was prosecuting a suit against Andries Andriessen, either a Swede or a Finn. The Court decided that the matter, the particular nature of which we do now know, should be adjusted by arbitrators.(56 J. Munsell, Collections on the History of Albany, IV., p. 164. Ibid., I., p. 28f.)

In 1667, his 1st wife ( Neeltje Seegerz) died.57 There was poverty in his home. The Church records of Albany state that his wife had received aid from the deacons. Also after her death the deacons continued to aid the home of Carelsen. In December, 1667, and January, 1668, the records state that the deacons paid "17 guilders and 10 stivers for beer furnished to Hans de Noorman." In November, 1668, it is recorded that the deacons furnished "bread to Hans de Noorman."(58 The Records of New Amsterdam 1653-1674, VI., p. 634. For other data see Collections on the History of Albany, IV., pp. 85, 164, 244, 319. Collections of the New York Genealogical and Biographical Society, I., pp. 35, 36.)

Hans Carelsen Tol I remained a widower for about four years. On April 1, 1671, he re-married, in New Amsterdam(NYC), Geertje Teunis, widow of Cors Jansen.59

In April, 1685, she was married to Francisco Anthony(.60 Ibid)

Hans Carelsen must have died some time before this.

in 30 May 1673 Hanse Carlse Toll sold a lot of land in Albany to Hendrick Gerritsen Vermuelen.....noted in Early Records of City and County of Albany, Notarial papers I and II, item # 208, pg 407-408, By Pearson and VanLaer also other items in same reference source ie pgs 112 (12 Sept 1661 shown as having a financial obligation to Fort Orange (Albany) for 40 fl) , pg 152 (April 1662 named in contract to deliver boards by sloop), pg 166 (named in suit as witness in death of Corn Seegersz son by Constapel), pg 202 ( 1663 sold house in village of Beverwyck but not lot on which it stands), pg 260 (named in will of Cornelius Seegersz as son in law)

Jan Carelszen, whose name as settler in Esopus appears first 1662, came from Langesund, Norway, eighteen miles from Skien.(note: this subject may be a younger brother of our Hanse Carlse/Carlsen Toll ....he is from Langesund, Norway and by his name is "the son of Carl" ) Both subjects were from Langsund, Norway and both resided during the same time period in the Esopus/Wiltwyck (Kingston) NY area.  
His wife was Helena Hendricks/Hendrix, sometimes was called Helena Rustenburg. In 1684 he was a porter or carman in New Amsterdam. March 29, in that year, he and fifteen other carmen were discharged by the common council for refusing to obey certain orders and regulations. But on April 6, he and two others were re-admitted as carmen on condition of paying a fine of six shillings and conforming to the laws.  
Jan and Helena had several children: Carl was baptized April 25, 1677; Lucretia, in 1679; Lucretia, January 12, 1681; Henricus, March 11, 1683; Johannes, June 29, 1684; Petrus, December 11, 1687; Ibel, June 22, 1690. May 21, 1693 Carelszen and his wife were sponsors at the baptism of twins belonging to Charles Peters and Maria Thomas.(61 The New York Genealogical and Biographical Record, XIV., p. 75. Van Rensselaer Bowier Manuscripts, p. 810. Ibid., p. 442.)

(Note: It is not known conclusively that the above Jan Carlezen was the younger brother of Hans Carlse Toll, but he was noted in records as coming from the exact same area in Norway, lived at the same NY area and during the same time period. With the facts of the naming patronymics, area in Norway, time period and like NY residences, the facts point to these two subjects as being brothers. DT 6/07)

Sweris Dirxsz came to New Netherland in 1659. He was from Sweden. He came over in "de Otter" which sailed on February 17, 1659. 734 In the court records of New Amsterdam he is called Severus Dirckszen. With two others he appeared, on March 28, 1662, as witnesses for a Geertje Teunis, who had been accused of tapping (tapping a keg of

beer) on the day of General Fast, March 15. Dirckszen and his companions testified that she did not tap on the day of General Fast when they were at her place. After hearing the parties concerned, the Court dismissed the case, but ordered that a negro who had falsely accused Geertje Teunis should be imprisoned.<sup>735</sup>

(It appears from historical records that Geertje Teunis operated some sort of tavern or "house" in New Amsterdam (NYC) prior to her 1671 marriage to Hanse Carlse TOLL as evidenced from her being sued in that capacity...this is logical in that such a house at that time would have been a prime location to meet TOLL who was a ship Captain and most undoubtedly he would have frequented such an establishment, (bawdy) and is further evidenced by the above facts in which TOLL is shown as having being supplied beer by the church, showing his penchant for drinking)

During insense research into this Toll family, a family lineage that appears in the Schenectady Co area by the name of Carely appears just after the Revolutionary War period....given the DRC Church records shown above of Hans Carely widow of Neeltie Cornelius at the DRC/New Amsterdam.....it is possible that another unknown lineage adopted the name Carely and it remained until that time...ie:

Joseph Carley, a veteran of the Continental army, came after the Revolution, and built on Front Street.(rev war pension # S44371...series M805, roll 161, image 117 NARA, also Bounty land record 6898 for 100 acres) above subject himself was pensioned 1st April 1818..as per abovr file S44371..

His son was Gerardus I. Carley, the partner at one time of DeGraff, Walton & Co, and the father of Mr. Joseph G. Carley of this city. (No further information is known on this Carely lineage)

The Carley name likeness to the above Hans Carely (Carlse) Toll is not proven and may be coincidence....or NOT???? To be proven !!!!!!!!!!!!!

\* FamilySearch Ancestral File has his birthplace as Langesund, Skagarack, Norway, but without any citation. Toll-Bauer Family Tree on Ancestry.com has Langesund, Telemark, Norway (which is now part of Bamble (city), Telemark (county), Norway). 2 sources cited (but not visible). #### \* The Toll Family

1. Hans Carelsen Toll, a Norwegian, the first settler of the name, operated a cargo vessel between New Amsterdam, Wiltwyck, and Beverwyck, as early as 1658. He was known as Carelsen the Noorman and as Hans Carelson van Langesund (van Langesant), Langesund being a town in Norway.

He appears in 1662 as a resident of Bevenyck and as husband of Neeltje Cornelis daughter of Cornelis Seegersz, van Voorhout (van Egmont) and his wife Brechie Jacobsdr.

His house in Wiltwyck was burned in the second Esopus war in 1663. His house in Beverwyck was located in the vicinity of the highway and Pearl Street. It was granted to another settler in 1671, due to his apparent neglect.

Neeltje Cornelis died in 1671 or before, and Hans Carelsen remarried in New York to Geertje Tennis, widow of Cors Janszen.

In 1673 he sold his lot on the hill in Albany. He died prior to 20 May 1685, when his second wife remarried. He was the father of Carel Hansen Toll and Rachel Hanse Toll, of Schenectady.

\* Hans Carel appears to be a party to a transaction in 1662. In the body of the Text, "Hans Carelsz NOORMAN makes himself responsible for the delivery of the said boards & slabs" [1] The footnote at the bottom of the page states: "[1] Apparently the same person as Hans Carrelsen van Langesont (i.e. Langesund, a town of Norway, on the Skager-Rack), mentioned in the Dutch Records of Kingston, revised translation by Samuel Oppenheim, p.36."

This re-inforces the idea that he was originally Norwegian.

It may also be the source for the Note "The Toll Family 1."

\* Agreement between the relatives of the late Seger Cornelissen van VOORHOUT and Folckertje Juriaensen, sister-in-law of Andries Herbertsen Constapel, the parties of the first part engaging not to prosecute said Constapel for the slaying of Seger Cornelissen

...Cornelis Sergersen belonged to the famous Egmond family of which the Jacobsz's daughter, married people, father and mother of the late Serger Cornelisz van VOORHOUT; [1] Jannetie Theunisz's daughter van Vechten, widow of said Serger Cornelisz, assisted by Theunisz Dircksz Van Vechten, her father, and Dirck Theunisz, her brother; Cornelis Cornelisz van VOORHOUT, brother of said Serger Cornelisz, deceased; Jacob Schermerhoorn, husband and guardian of Jannetie Cornelisz's daughter van VOORHOUT; and Hans Cornelisz, [2] husband and guardian of Neeltie Cornelis van VOORHOUT, as well as for themselves as herein representing and undertaking for Francois Boon, husband and guardian of Lysbet Cornelisz van VOORHOUT, sister of said Cornelisz van VOORHOUT, deceased, and all other their relatives, blood relations and kindred, of the first part; and Folckertje Juriaensz, wife of Jan Franssen van Hoesen....

[2] He is also referred to as Hans Carelsen NOORMAN and was probably the same person as Hans Carelsen van Langesont (Langesund), mentioned in the Dutch Records of Kingston, revised translation by Samuel Oppenheim, p.36, and Hans Carolusen, whose house in Witwyck was burned in the second Esopus war in 1663; see Doc. rel. to Col. Hist. N.Y., 13 :247. He was the ancestor of the TOLL family in Schenectady.

Carelsen was a fur-trader. An entry under date of August 6, 1657, shows that he sent down from Albany to New Amsterdam 2,300 beavers, and in the following month of September 1,100 beavers.(49 The Records of New Amsterdam 1653-1674, III., p. 31.)

In August, 1659, Geertje Hendricks sued him for a balance of 12 beavers and fl. 18 in seawan. In his defense Carelsen claimed that he had paid her more than what belonged to her, as the other half concerned Jacob Coppe, deceased. The contract was then produced in court, whereupon Carelsen admitted that he owed the sum demanded. He said, however, he could not pay it at present. But the court ordered him to pay it if he wanted release from arrest.(50 Ibid., III., p. 387.)

In October, 1661, he was again engaged in litigation, this time suing Pieter Ryverdinck, who owed him a sum of money for freighting goods to Ft. Orange.(51 Year Book of the Holland Society of New York, 1900, p. 140. [p.45])

On April 22, 1662, he signed his name as a witness at the conveyance of a yacht.(52 J. Munsell, Collections on the History of Albany, IV., p. 319.)

In 1662-1663 he wanted to sell his house near Beverwyck. We have an imperfect and unsigned paper stating the condition on which he proposed "to sell at a public sale to the highest bidder his house and lot lying near the village of Beverwyck by the side of the hill on the plain where he at present dwells."(53 New York Colonial Documents, XIII., p. 247.)

On June 7, 1663, his house at Wiltwyck was burnt by Indians.(54 The Records of New Amsterdam 1653-1674, V., p. 126.)

In January, 1664, a carpenter brought suit against Carelsen for the amount of twenty-four and a half guilders for wages

earned on the boat Carelsen was sailing. Though it was shown that the plaintiff had run away from his work, the court ordered Carelsen to pay the sum sued for. (55 Ibid) He had engaged the carpenter for a year at the rate of 26 gl. per month. (Ibid., VI., p. 43)

. In 1666 Carelsen was prosecuting a suit against Andries Andriessen, either a Swede or a Finn. The Court decided that the matter, the particular nature of which we do now know, should be adjusted by arbitrators. (56 J. Munsell, Collections on the History of Albany, IV., p. 164. Ibid., I., p. 28f.)

In 1667, his wife died.<sup>57</sup> There was poverty in his home. The Church records of Albany state that his wife had received aid from the deacons. Also after her death the deacons continued to aid the home of Carelsen. In December, 1667, and January, 1668, the records state that the deacons paid "17 guilders and 10 stivers for beer furnished to Hans de Noorman." In November, 1668, it is recorded that the deacons furnished "bread to Hans de Noorman." (58 The Records of New Amsterdam 1653-1674, VI., p. 634. For other data see Collections on the History of Albany, IV., pp. 85, 164, 244, 319. Collections of the New York Genealogical and Biographical Society, I., pp. 35, 36.)

Hans Carelsen remained a widower for about four years. April 1, 1671, he married, in New Amsterdam, Geertje Tennis, widow of Core Jansen.<sup>59</sup> In April, 1685, she was married to Francisco Anthony. (60 Ibid) Hans Carelsen must have died some time before this.

Jan Carelszen, whose name as settler in Esopus appears first 1662, came from Langesund, Norway, eighteen miles from Skien. (note: this subject may be a brother of our Hanse Carlse/Carlsen Toll ....he is from Langesund, Norway and by his name is "the son of Carl" )

His wife was Helena Hendricks, sometimes called Helena Rustenburg. In 1684 he was a porter or carman in New Amsterdam. March 29, in that year, he and fifteen other carmen were discharged by the common council for refusing to obey certain orders and regulations. But on April 6, he and two others were re-admitted as carmen on condition of paying a fine of six shillings and conforming to the laws. Jan and Helena had several children: Carl was baptized April 25, 1677; Lucretia, in 1679; Lucretia, January 12, 1681; Henricus, March 11, 1683; Johannes, June 29, 1684; Petrus, December 11, 1687; Ibel, June 22, 1690. May 21, 1693 Carelszen and his wife were sponsors at the baptism of twins belonging to Charles Peters and Maria Thomas. (61 The New York Genealogical and Biographical Record, XIV., p. 75. Sweris Dirxszen came to New Netherland in 1659. He was from Sweden. He came over in "de Otter" which sailed on February 17, 1659.<sup>734</sup> In the court records of New Amsterdam he is called Severus Dirckszen. With two others he appeared, on March 28, 1662, as witnesses for a Geertje Teunis, who had been accused of tapping (tapping a keg of beer) on the day of General Fast, March 15. Dirckszen and his companions testified that she did not tap on the day of General Fast when they were at her place. After hearing the parties concerned, the Court dismissed the case, but ordered that a negro who had falsely accused Greetje Teunis should be imprisoned.<sup>735</sup>
